

ARTICLES OF AMENDMENT OF HOSPICE FOUNDATION OF NORTHWEST FLORIDA, INC.

STATE OF FLORIDA COUNTY OF ESCAMBIA

We, the undersigned officers of Hospice Foundation of Northwest Florida, Inc., a not for profit corporation organized under the laws of the State of Florida (the "Corporation"), do hereby make and attest these Articles of Amendment, and certify as follows:

- (1) The name of the Corporation is Hospice Foundation of Northwest Florida, Inc.
- (2) The following amendment has been adopted in accordance with the requirements set forth in Chapter 617 of the Florida Statutes:

The first sentence of Article I of the original Articles of Incorporation of the Corporation is deleted in its entirety, and replaced with the following first sentence of Article I:

ARTICLE I

The name of this corporation shall be Covenant Hospice Foundation, Inc. ("Corporation"). All references in these articles to Hospice of Northwest Florida, Inc., shall mean Covenant Hospice, Inc., in accordance with the name change of the former to the latter filed with the Secretary of State of Florida on or about March 30, 2001.

- (3) The date of adoption of this amendment is December 12, 2001.
