The following plan of merger is submitted in compliance with §617.1105, F.S.

ARTICLE I – SURVIVING CORPORATION

The name of the surviving not for profit corporation is COVENANT HOSPICE FOUNDATION, INC., which was formed under the laws of and is subject to the jurisdiction of Florida.

ARTICLE II – MERGING CORPORATION

The name of the merging corporation is HOSPICE FOUNDATION OF NORTHWEST FLORIDA, INC., which was formed under the laws of and is subject to the jurisdiction of Florida.

ARTICLE III – TERMS OF MERGER

The merger shall be effective as of the date of filing the Articles of Merger with the Florida Secretary of State (the "Effective Time"). At the Effective Time, COVENANT HOSPICE FOUNDATION, INC. ("Covenant Hospice Foundation") shall be merged with and into HOSPICE FOUNDATION OF NORTHWEST FLORIDA, INC. ("HFNWFL") with Covenant Hospice Foundation being the surviving corporation. The separate corporate existence of HFNWFL and the membership interests of HFNWFL shall cease at the Effective Time, and all assets, liabilities, rights, privileges and franchises of HFNWFL shall inure to Covenant Hospice Foundation. The Bylaws of Covenant Hospice Foundation in effect immediately prior to the merger shall become the Bylaws of the surviving company following the merger.
