Florida Records Management Association

Amends Article III Purpose(s) by adding the following wording:

The association was organized exclusively for educational purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law. The association shall not carry on any other activities not permitted by an organization exempt for Federal income tax under Section 501 (c) (3) of the Internal Revenue Code or the corresponding provisions of any future United States Internal Revenue Law.

No part of the net earnings of this organization shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the Association shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in the furtherance of the purposes in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including in publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office

Add Article VIII- Dissolution

In the event of dissolution of the Association, the residual assets of the Association will be turned over by the Executive Committee in office at the time time of dissolution to one or more organizations which themselves are exempt as organizations described in Sections 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code or corresponding sections of any prior or future Internal Revenue Code or Federal, state, or local government for exclusive public purposes.
