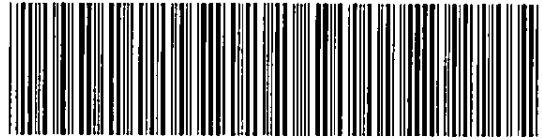

ARTICLES OF INCORPORATION
OF

THE SAND KEY CIVIC ASSOCIATION, INC.

The undersigned, for the purpose of forming a nonprofit corporation under Florida Statutes Chapter 617, do hereby make and adopt the following Articles of Incorporation.

ARTICLE I. CORPORATE NAME.

The name of this Corporation is:

THE SAND KEY CIVIC ASSOCIATION, INC.

ARTICLE II. NOT FOR PROFIT

The Corporation is a nonprofit corporation under the laws of the State of Florida. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its Members, Directors or Officers, except to the extent permissible under law.

ARTICLE II. PURPOSES

The Corporation is organized, and shall be operated exclusively for, the following purposes:

A. To monitor and influence legislation that effects the development of Sand Key, Clearwater, Florida and areas contiguous thereto with a view towards its preservation and the continued care of Sand Key's beaches, bays and public access.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

C. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

ARTICLE III. LIMITATION

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its Members, Directors or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth

ARTICLE IV. TERM OF EXISTENCE.

This Corporation shall have perpetual existence.

ARTICLE V. MEMBERS

The qualification of Members and the manner of their admission shall be as regulated by the Bylaws.

ARTICLE VI. BOARD OF DIRECTORS.

The management of the Corporation shall be vested in a Board of Directors. This Corporation shall initially have six (6) Directors. The number of Directors may be increased or diminished from time to time in accordance with the Bylaws adopted by the Directors, but shall never be less than three (3). The name of the initial Directors of this Corporation and their respective street addresses are:

The persons named as initial Directors shall hold office for the first year of existence of this Corporation or until his successors are elected or appointed and have qualified, whichever occurs first.

ARTICLE VII. OFFICERS

The Officers of the Corporation shall consist of a President, Secretary, Treasurer and such other Officers and Assistant Officers as may be provided in the Bylaws. Each Officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time and in such manner as may be prescribed by the Bylaws.

ARTICLE VIII. REGISTERED AGENT AND INITIAL REGISTERED OFFICE.

The Corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation or any amendment to them, and all rights and privileges conferred upon the Members, Directors and Officers are subject to this reservation. The Articles of Incorporation may be amended in accordance with the provisions of the laws of the State of Florida, as amended from time to time, unless more specific provisions for amendments are adopted by the Corporation pursuant to law.

ARTICLE XI. INDEMNIFICATION

The Corporation shall indemnify each Officer and Director, including former Officers and Directors, to the full extent permitted by the laws of the State of Florida.

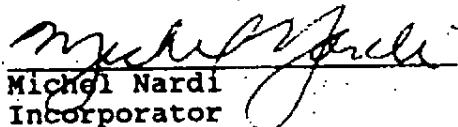

ARTICLE XIII. NONSTOCK BASIS

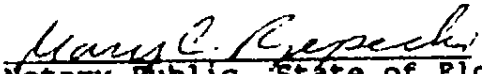
This Corporation is organized on a nonstock basis. This Corporation shall not issue shares of stock.

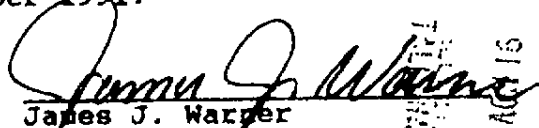
