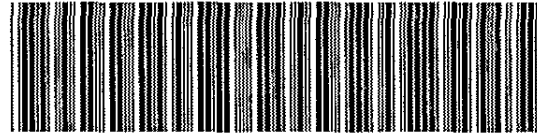

ARTICLE III PURPOSE

- 1.1** This is a non-stock, non-profit corporation. The purpose of the corporation is to engage in any lawful act or activity for which non-profit corporations may be organized under the laws of the State of Florida.
- 1.2** The corporation is organized exclusively for charitable, religious, educational, and scientific, purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- 1.3** The purpose shall include, but not be limited to: the development and administration of programs designed to assist and encourage women and men through education; support women in confronting and dealing with the physical, spiritual, emotional, economic and social problems associated with pregnancy; develop and administer programs designed to assist pregnant women who desire to carry their unborn child to term to include support and medical services that empower them to make healthy choices; programs to assist in recovery from a previous abortion; programs to educate and encourage abstinence until marriage.
