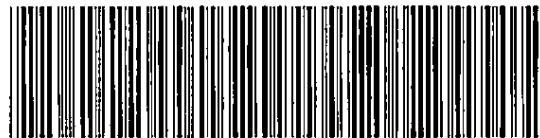

**ARTICLE I**

**NAME**

The name of this Society shall be the Garden Club of Fort Pierce Inc.

**ARTICLE III**

**OBJECT**

The object of this Society shall be to further the education of members and  
the public in the fields of gardening, horticulture, botany, landscape and floral  
design; to promote the conservation of natural resources; to encourage civic  
beautification; and to advance environmental education and nature study.

**ARTICLE IV**

**MEMBERSHIP**

Membership in this corporation shall be composed of such persons in the State  
of Florida under such terms and conditions and such rules as may be prescribed  
from time to time by the By-Laws of this corporation.

**ARTICLE V**

**DIRECTORS**

**ARTICLE VI**

The affairs of this corporation shall be managed by a Board of Directors consist-  
ing of not less than five (5) nor more than twenty-five (25) members, the  
number of which shall be determined by the By-Laws of the corporation and which  
directors are to be elected at the annual meeting of the corporation from among  
the members thereof in such manner as the By-Laws shall provide. Vacancies in  
the Board of Directors, as well as vacancies in the offices of the corporation  
shall be filled in such manner as may be prescribed in the By-Laws.

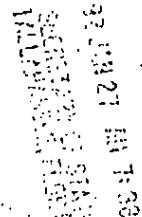
