## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF DOCTORS MEMORIAL HOSPITAL (A Florida not for profit corporation)

Pursuant to the provisions of section 617.1002, Florida Statutes, this corporation adopts the following articles of amendments to its articles of incorporation:

First: Amendments adopted:

## ARTICLE VIII

## Appointment and Vacancies

In the event of a vacancy or vacancies on the Board of directors, a successor's) shall be appointed by a majority vote of the Board of County Commissioners from among those persons nominated by the remaining Board of Directors. For each vacancy, (other than the director positions designated for the Chief of the Medical Staff and the hospital employee representative), the remaining Board of Directors shall solicit recommendations from the Board of County Commissioners and make a general request for applications to fill the vacancy or vacancies from the public "at large". The remaining Board of Directors shall consider all applications and then, by a majority vote, forward to the Board of County Commissioners a list of not less than three (3) nominees for each vacancy. If the number of applications received by the remaining Board of Directors for consideration are insufficient for compliance with the minimum number of nominees to be submitted to the Board of County Commissioners, then the remaining Board of Directors shall submit the number of applicants received.

In the event of a vacancy in the director position designated for the hospital employee representative, the hospital employees shall select a replacement director by a majority vote of the

employees which shall be conducted in a method and manner approved by the Board of Directors.

The director position designed for the Chief of the Medical Staff shall automatically and continuously be occupied by the physician who is Chief of the Medical Staff pursuant to the Medical Staff Bylaws.
