EXHIBIT "A"

ARTICLE VI

Board of Directors

A. The affairs of the Association shall be managed by a board of directors consisting of five (5) directors. The members of the board shall be members of the Association but need not be residents of the State of Florida. Election of directors shall be by a plurality vote. At the annual meeting in the year 1999 (which is the first year in which five (5) directors will serve), five (5) directors shall be elected, three (3) to serve a two year term and two (2) to serve a one year term. Thereafter, two (2) directors will be elected in even numbered years and three (3) directors will be elected in odd numbered years, each director to serve a two (2) year term.
