Pursuant to provisions of Section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The Articles of Incorporation for Heather Glen Owners' Association, Inc. ("Association") have been amended as follows:

(Words in strike-through type are deletions from existing text; underlined words are additions.)

ARTICLE II - PURPOSE AND POWERS OF THE ASSOCIATION

(d) Borrow money, if deemed necessary for the maintenance and welfare of the community by the Board of Directors and approved by a majority of the Board of Directors. ~~The Board is authorized to and with the assent of not less than two thirds (2/3) of the votes of each class or members present and voting,~~ mortgage, borrow money, pledge, deed in trust, or hypothecate any or all of its real or personal property as security for money borrowed or debts incurred; and

- 2. The date of adoption of this amendment was October 12, 2023.

- 3. This amendment was approved and adopted by the Association's board directors as is authorized by Article XI of the Association's Articles of Incorporation.
