**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF

THE UNDERSIGNED, Lori Costantino-Brown, President of BRIDGES OF AMERICA - THE SANFORD BRIDGE, INC., a Florida not for profit corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Articles of Incorporation of the Corporation:

ARTICLE FIRST: The name of the Corporation is BRIDGES OF AMERICA - THE SANFORD BRIDGE, INC., and the Corporation's Florida document number is N93000000891.

ARTICLE SECOND: ARTICLE IV - MEMBERSHIP of the current Articles of Incorporation is hereby deleted in its entirety and restated as follows:
