EXHIBIT "A"

- Association, Inc. are amended as follows (the language added is <u>underlined</u>; the language deleted is <u>struck out</u>):
- 1) Article VII of the Articles of Incorporation is amended as follows:

VOTING RIGHTS

The Association shall have one two (2) classes of voting membership:

* * *

- Class B. The Class B member shall be the Declarant, and shall be entitled to two hundred (200) votes. The Class B membership shall cease on the happening of one of the following events, whichever occurs earlier:
 - (a) Four (4) months after 75% of the Units that will be ultimately operated by the Association have been conveyed to Unit purchasers; or
 - (b) Five (5) years following conveyance of the first Unit in the Properties to a Unit purchaser; or,
 - (c) Such earlier date as Declaration may determine.
- 2) Article VIII of the Articles of Incorporation is amended as follows:

BOARD OF DIRECTORS

The affairs of this Association shall be managed by a Board of Directors consisting of not less than three (3) nor more than nine (9) persons who shall need not be members of the Association. The first Board shall consist of three (3) members. Thereafter the number of Directors may be increased to a maximum of nine (9) by a majority vote of the Board of Directors.

* * *

The Directors named in these Articles shall serve until the first election of Directors, and any vacancies in their number occurring before the first election shall be filled by the Class "B" Member. The Class B Member

shall have the right to remove and replace Directors until the first election of Directors. The names and addresses of the members of the first Board of Directors who shall hold office until their successors are elected and have qualified, or until removed, are as follows:
