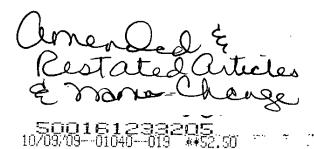

AMENDED AND RESTATED ARTICLES OF INCORPORATION

OF

HIBISCUS CHILDREN'S CENTER FOUNDATION, INC.

A FLORIDA NOT-FOR-PROFIT CORPORATION

DOCUMENT NUMBER N 93000002328

ARTICLE I

NAME

The name of this corporation shall be:
HIBISCUS CHILDREN'S CENTER FOUNDATION, INC.

ARTICLE II

TERM OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE III

PURPOSE

- A. This Corporation is organized exclusively for charitable, scientific, literary, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code (or any successor section) and for the additional purposes of:
 - Soliciting from individuals, corporations, and civic organizations contributions to serve abused, abandoned, and neglected children of the region of the State of Florida known as the Treasure Coast and the Gold Coast and any other region selected by the Board of

Directors from time to time and to use those contributions to serve abused, abandoned, and neglected children in such areas of Florida.

- To make contributions to HIBISCUS CHILDREN'S CENTER, INC.,
 a Florida Not For Profit Corporation, exempt from tax pursuant to Internal Revenue Code Section 501(c)(3) to assist that corporation in accomplishing its charitable purpose of serving abused, abandoned, and neglected children.
- B. Notwithstanding any other provision contained in these Articles of Incorporation, this Corporation shall not conduct any other activities not permitted to be carried on by an organization exempt from Federal Income tax under Section 501(c)(3) of the Internal Revenue Code or successor section.
- C. Notwithstanding any other provision contained in these Articles of Incorporation, no substantial part of the corporation's activities shall consist of attempting to influence legislation by propaganda, or otherwise attempting to influence legislation in any fashion not permitted under applicable Treasury Regulations. The Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office and shall further comply with the requirements of all applicable Treasury Regulations.
- D. This Corporation, not for profit, shall have the power to acquire by gift, devise, bequest, purchase, lease or otherwise, and to hold, own, occupy, use, manage, improve, develop, maintain, lease, sell, mortgage, transfer, invest in or reinvest in, or otherwise deal with any real or personal property of whatever kind and description and wherever situated, or with any estate or interest, legal or equitable, in the property, or to borrow money and to make, accept, endorse, execute and issue promissory notes and other obligations in payment for property acquired or money borrowed;

- and to do all other acts as are necessary or convenient to carry out the purposes set forth in these Articles.
- E. This Corporation, not for profit, may conduct and transact any activity lawfully authorized and not prohibited by Chapter 617, Florida Statutes, entitled "The Florida Not For Profit Corporation Act", as the same may be, from time to time, amended.

ARTICLE IV

DIRECTORS

- A. This Corporation is authorized to issue membership in this Corporation as authorized in Section 617.0601 of the Florida Statutes. The qualifications for directors and the manner of their admission will be regulated by the Bylaws of the Corporation.

AMENDMENTS

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed to them by the members and approved at a members' meeting by at least a majority of the membership entitled to vote, unless all of the directors and all of the members sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

ARTICLE X

LIMITATION ON THE DISTRIBUTION OF CORPORATE ASSETS AND NET EARNINGS

- A. No part of the Corporation's net earnings shall inure to the benefit of, or be distributable to, its directors, members, officers or other private individuals as prescribed in applicable Treasury Regulations, provided, however, the Corporation is authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes of this Corporation.
- B. In the event of the Corporation's dissolution, the Corporation's residual assets will be:
 - Distributed to HIBISCUS CHILDREN'S CENTER, INC., a Florida Not For Profit Corporation;

- Distributed for one or more exempt purposes for which this
 Corporation was organized;
- Turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and
 170(c)(2) of the Internal Revenue Code, or successor sections; or
- 4. Distributed to Federal, State, or local government exclusively for public purposes.

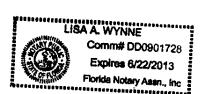
