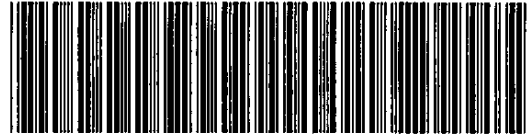

The amendment adopted is as follows:


The name of the corporation of shall be changed to the following:

The above amendments have been unanimously adopted by the Board of Directors of the corporation at its annual meeting held on June 10, 2006.


