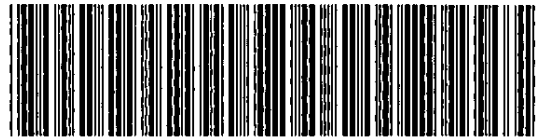

The board of directors of Calvary Chapel of Orange Park, Inc. have agreed to amend the Articles of Incorporation with the addition of two paragraphs under the "XIII Resolution." 1. Calvary Chapel of Orange Park, Inc. will remain a "local" organization within the meaning of Section 73.7000 of the rules and regulations of the Federal Communications ("FCC") so long as Calvary Chapel of Orange Park, Inc is an applicant for, or the licensee of, a noncommercial educational FM radio station awarded, or sought to be awarded, to Calvary Chapel of Orange Park, Inc under the "Established local applicant" criteria set forth in Section 73.7003(b)(1) of the FCC's rules and regulations. Specifically, Calvary Chapel of Orange Park, Inc will maintain its headquarters or the residences of 75 percent of its board members within 25 miles of the reference coordinates (as defined in the FCC's rules) of the communities of license specified in the radio station authorization granted to Calvary Chapel of Orange Park, Inc by the FCC by virtue of a claim under such Established local applicant preference.

2. Calvary Chapel of Orange Park, Inc will, should it be awarded a preference by the FCC under the "Local diversity of ownership" preference set forth in Section 73.7003(b)(2) of the FCC's rules and regulations, maintain local diversity so long as it is the licensee of any noncommercial radio station awarded to it under such Local diversity of ownership preference. Specifically, neither Calvary Chapel of Orange Park, Inc nor any officer or director of Calvary Chapel of Orange Park, Inc will acquire an attributable interest (as defined in Section 73.7000 of the FCC's rules) in any broadcast or translator station whose principal community contour overlaps that of any station authorized by the FCC to Calvary Chapel of Orange Park, Inc under such Local diversity of ownership preference.
