RESTATED AND AMENDED ARTICLES OF INCORPORATION W 18 AM 9: 06

Pursuant to the provisions of Section 617.1007, Florida Statutes, **DAYTONA BEACH BLACK NURSES' ASSOCIATION, INC.**, a Florida Not for Profit corporation, whose articles of incorporation were filed by the Florida Department of State on November 8, 1993, by resolution duly adopted a majority vote of the Board of Directors to the membership and adopted by a two-thirds (2/3) vote of all members present, adopt the following restated and amended articles of incorporation:

ARTICLE I - Name

The name of the corporation is:

DAYTONA BEACH BLACK NURSES' ASSOCIATION, INC.

ARTICLE II - Term of Existence

The corporation shall have a perpetual existence.

ARTICLE III - General and Specific Purposes

The specific and primary purposes for which this corporation is formed is:

- 1) To provide a forum through which nurses of African heritage can collectively and cooperatively unite in order to address health issues relevant to the African-Americans in Volusia County, Florida;
- 2) To provide educational programs which focus on heath issues and health problems impacting African-Americans;
 - 3) To provide financial support to nursing education departments;
- 4) To participate in health screening programs sponsored by other health care organization in the community;
 - 5) To compile and maintain a directory of nurses of African heritage;
 - 6) To recruit African-Americans for the nursing profession;
- 7) To act as health care advocates for quality care to local persons of African descent:
- 8) To serve as a local nursing body to influence legislation and policies that affect persons of African descent, and work cooperatively and collaborative with other health works and organizations to this end;

- 9) To ensure a constant succession of nurses of African descent in the nursing profession through recruitment and career counseling efforts;
- 10) To act as the vehicle for unification of nurses of African descent through collaboration and communication with other groups with of our common heritage;
- 11) To provide the impetus and means fo nurses of African descent to write and publish matters of professional relevance;
- 13) The general purposes for which this corporation is formed are to operate exclusively as a charitable society, by the distribution of its funds for those purposes, as stated above which will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code 1986 or corresponding provisions of any subsequent federal tax laws, including, for those purposes, the making of distributions to organizations which qualify as tax-exempt organization under that Code.

This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in political campaign on behalf of any candidate for public office.

12) To perform any and all other lawful things incident and kindred to the above purposes.

ARTICLE IV - Qualifications of Members

- 1) Membership The membership shall consist of those nurses (active and retired) and nurses who express commitment to the purpose and philosophy of the Daytona Beach Black Nurses Association, and pay annual dues as determined from time to time by the association. The initial dues are Twenty-five (\$25.00 dollars).
 - 2) Classification -
- A) There shall be four (4) classes of membership: licensed, nursing students, retired, and affiliates.
- 1) Licensed members may be registered nurses, licensed practical nurses, and/or licensed vocational nurses.
- 2) nurses to lives are those persons who are currently in enrolled in a nursing program and not yet license.

- 3) Retired members are those persons for previously licensed but no longer maintain an active nursing license.
- 4) Affiliated members are those who are not nurses nor nursing students but who express an interest in supporting the purpose and philosophy of the Daytona Beach Black Nurses' Association.
- B) Persons who meet with the qualifications become active members of the Daytona Beach Black Nurses' Association.
- C) Affiliated members may not hold elected of this or have chapter voting privileges.
- D) Affiliated members shall not be counted by the Daytona Beach Black Nurses' Association in determining a quorum for voting purposes.
- E) Membership in the national black nurses association is not a prerequisite for membership in doubt Daytona Beach Black Nurses' Association.

3) Good Standing

A member in good standing is one whose cartoons are paid, who complies with the provisions of the by-laws, and who is otherwise entitled to full voting privileges.

- 4) Inactive
- A) Privileges of membership shall expire in August of each year and a member shall become inactive if dues are not paid.
- B) Inactive members shall lose voting rights at all the privileges of membership.

5) Disciplinary Action

Any member whose conduct has proven injurious to the Daytona Beach Black Nurses' Association or its purposes shall be subject to disciplinary action, as specify in the by-laws or other parliamentary authority.

ARTICLE V - By-Laws

The By-laws of this corporation shall be drafted by the board of Directors and submitted to the membership for approval by two-thirds (2-3) majority vote of the members present at the meeting called for that purpose. The By-laws may be amended or rescinded in the same manner and by two-thirds (2/3) majority vote of the members present at a meeting called for that purpose.

ARTICLE VI - Amendments to Articles

Amendments to the Articles of Incorporation shall be by a majority vote of the Board of Directors to the membership and adopted by a two-thirds (2/3) vote of all members present and entitled to vote a duly called meeting of the membership.

ARTICLE VII - Registered Office/Principal Office and Registered Agent

The address of the registered office of the corporation is 808 S. Dr. M. L. King Jr. Blvd. Daytona Beach, Volusia County, Florida 32114. The principal place of business is the same.

The registered agent at such address is Lizzie M. Flynt.

ARTICLE VIII - Board of Directors

There shall not be less that nine (9) Directors of the corporation, as determined by the By-laws, who shall be responsible for managing the affairs thereof. The directors shall be elected officers, which includes the second vice-president (student representative) and the immediate past president who shall be elected as provided in the By-laws.

The term for each member of the Board of Directors and shall end at the annual meeting that more closely coincides with said term, or as otherwise determined by the Bylaws.

ARTICLE IX - Income of the Organization

No part of the income and/or profits of this corporation shall be distributed to its members, directors, or officers.

ARTICLE X - AMENDMENTS TO ARTICLES

Amendments to the Articles of Incorporation shall be recommended by a majority vote of the Board of Directors to the membership, and adopted by a two-thirds(2/3) vote of all members present and entitled to vote at a duly called meeting of the membership.

ARTICLE - Dissolution of Corporation

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, (or corresponding provisions of any future United States Internal Revenue Law), or shall be distributed to a state or local government, for public purpose. Any such assets not

disposed of shall be disposed of by Court of competent jurisdiction in the county in which the principal office of the organization is located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

The above-restated articles of incorporation one restate and integrate and do not further amend the provision of this corporation's articles of incorporation. There is no discrepancy between the corporation's articles of incorporation as previously filed other than the omission of historical interest.
