

# Articles of Amendment

### Article II. Purposes and Objectives (amended)

A. To provide for the efficient and effective delivery of health services in Bradford, Union, Dixie, Gilchrist, Levy, Hamilton, and Suwannee Counties, and the rural areas of Alachua County through the integration of public and private resources and the coordination of health care providers.
