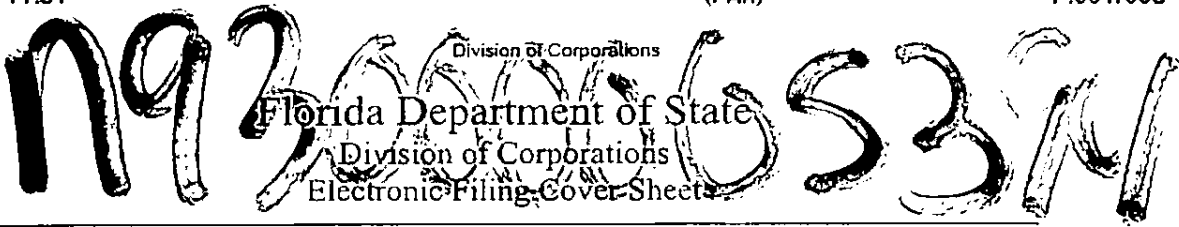

CERTIFICATE OF AMENDMENT TO
ARTICLES OF INCORPORATION
OF

MARTIN HOUSING ALLIANCE, INCORPORATED

WHEREAS, MARTIN HOUSING ALLIANCE, INCORPORATED its Articles of Incorporation on November 22, 1993; and

WHEREAS, the Board of Directors has voted to amend the Articles of Incorporation so that the corporation is now known as "ABILITIES AT SIERRA APARTMENTS, INC."

NOW THEREFORE, the Articles of Incorporation are hereby amended as follows:

1. Article I - NAME is amended to read:

"The name of the Corporation shall be ABILITIES AT SIERRA APARTMENTS, INC (hereinafter referred to as the "Corporation")."

2. Article VI is deleted in its entirety, and the following substituted:

"The affairs of the Corporation shall be managed by a Board of Directors consisting of not less than three (3), nor more than fifteen (15) in number who shall be elected by the members of the Corporation at the annual meeting. The Directors of the Corporation must at all times be members of the Corporation. No non-member of the Corporation may sit as a Director. The names and post office addresses of the current Board of Directors, who serve until their successors are duly elected are as follows:

- Diane McAdams
- Shirley Quinnell-Friedlander

Membership at all times shall be approved by the Board of Directors of ABILITIES INC. OF FLORIDA. In the event that a Director of the Corporation ceases to have the approval of ABILITIES INC. OF FLORIDA, such shall constitute automatic resignation as a Director of the Corporation."

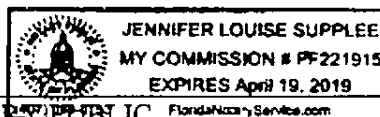
