# Amendment No. 2: Article I; and Article II, Section 1; Articles of Incorporation

## ARTICLE I. NAME

The name of the corporation shall be <u>KING</u> TARPON <u>PASS</u> CONDOMINIUM ASSOCIATION, INC. For convenience, the corporation shall be referred to in this instrument as the "Corporation."

## ARTICLE II. PURPOSE AND POWERS

Section 1. Purpose. The purpose for which the Corporation is organized is to provide an entity for the operation and governance of <u>King</u> Tarpon Pass Condominium (the "Condominium"), located upon lands in Lee Country, Florida, said property being described in the duly recorded Declaration of Condominium applicable thereto.

The Corporation shall not be operated for profit and shall make no distribution of income to its members, directors, or officers.
