





**ARTICLES OF AMENDMENT
OF
ARTICLES OF INCORPORATION
OF

The undersigned, Robert Felder, a Director of Jesus and You Outreach Ministries, Inc., a Florida not-for-profit corporation, on behalf of the Corporation hereby executes this Amendment in accordance with Florida Statute 607.1006 as follows:

1. The name of the Corporation is Jesus and You Outreach Ministries, Inc., a Florida not-for-profit corporation.
2. Article IV – PURPOSE of the Articles of Incorporation, is hereby amended to add the following:

“ The Corporation will engage in activities and outreach programs to benefit its community and its region. Activities will include but are not limited to the construction of a Neighborhood Resource Center.”
3. The above amendment was duly adopted by unanimous written consent of the Board of Directors dated March 18, 2002. There are no members entitled to vote on this amendment.
4. All other terms and provisions of the Articles of Incorporation of the Corporation as filed with the Secretary of State of the State of Florida on April 5, 1995 remain in full force and effect.

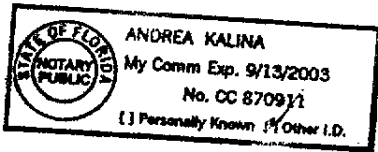
