**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF  
COPPERFIELD PROPERTY OWNERS ASSOCIATION, INC.**

Pursuant to the provisions of §617.1006, *Fla. Stat.*, Copperfield Property Owners Association, Inc. ("Association") adopts the following Articles of Amendment to its Articles of Incorporation.

**FIRST:      Amendment adopted:**

Article XI of the Articles of Incorporation of Copperfield Property Owners Association, Inc. ("Articles of Incorporation") is hereby amended as follows (additions are indicated by underlining; deletions are indicated by ~~strike-outs~~, omitted and unaltered provisions are indicated by ellipses):

...

Amendment of these Articles of Incorporation shall be made by the affirmative vote of the majority of Owners who are voting in person or by proxy at a meeting of the members at which a quorum has been attained (e.g., once a quorum of those Owners attending in person or by proxy has been obtained at a regular/annual or special meeting of the members of the Association, a majority of those Owners attending the meeting in person or by proxy may amend these Articles of Incorporation)~~require the assent of not less than sixty-seven percent (67%) of the total number of votes in each class membership.~~

**SECOND:**    The date of adoption of the Amendment was the 21<sup>st</sup> day of January, 20 14.

**THIRD:      Adoption of Amendment:**

Article XI of the Articles of Incorporation, entitled "Amendments", in effect prior to the adoption of the instant amendment, provides that Amendments to the Articles of Incorporation may be approved by not less than sixty-seven percent (67%) of the total number of votes in each class (of) membership.

The members of the corporation were entitled to vote on the Amendment. The members of the Association duly adopted the Amendment in accordance with the above-stated provision. **The number of votes cast for the Amendment was sufficient for approval.**
