

## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF MARCO ISLAND MARINA ASSOCIATION, INC.

The Articles of Incorporation of Marco Island Marina Association, Inc., a Florida not for profit corporation, shall be amended as shown below.

Article V of the Articles of Incorporation of Marco Island Marina Association, Inc. shall be amended to read as follows:

## ARTICLE V BOARD OF DIRECTORS

The affairs of the Marina Association shall be managed by a Board of Directors. The Board of Directors will consist of five (5) directors, each of whom shall be elected by the Slip Owners. The method of election of the Directors shall be as stated in the By-laws.

The foregoing amendment was adopted in accordance with the requirements of Section 617.1002, Florida Statutes, by a vote of the board of directors, at a meeting for which notice of the changes to be made was given, which meeting was held on April 7, 2003. There are no members entitled to vote on the proposed amendment. The number of votes cast for the amendment was sufficient for approval.
