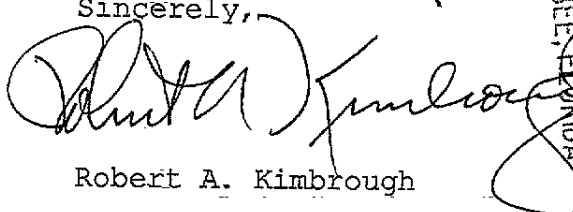

FIRST: Article I, Name be and is hereby amended to be as follows:

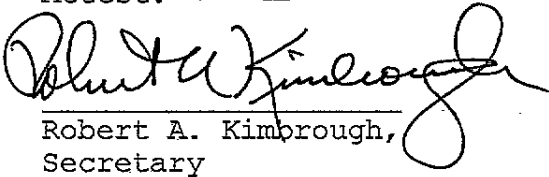

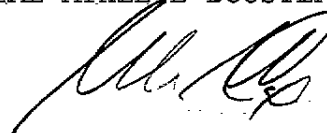
The name of the corporation is SPECIAL ATHLETE BOOSTERS, INC.

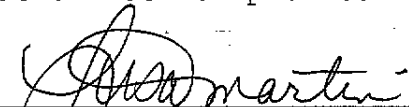
