ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORAITON OF BRIDGES OF AMERICA, INC.

ARTICLE FIRST: The name of the Corporation is BRIDGES OF AMERICA, INC., and the Corporation's Florida document number is N94000002415.

<u>ARTICLE SECOND</u>: ARTICLE IV - MEMBERSHIP of the current Articles of Incorporation is hereby deleted in its entirety and restated as follows:
