ARTICLES OF INCORPORATION  
OF

We, the undersigned, all of whom are of legal age, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida, applicable to corporations not for profit, under the following proposed Charter:

ARTICLE I  
NAME

The name of the corporation shall be GREATER PINEY GROVE BAPTIST CHURCH, INC., and it is located at 112 Huey Street, Wildwood, Florida 34785.

ARTICLE II  
DURATION

This corporation shall have perpetual existence unless it shall be dissolved according to the laws of the State of Florida.

ARTICLE III  
PURPOSE

The object and general nature of this corporation shall be to establish and maintain in the City of Wildwood, Florida, a Baptist Church, subject to the Church's Constitution and Bylaws. The primary purpose of the Church is to seek lost souls and bring them to Jesus, to religiously educate its members, and to promote the spirit of christianity and love throughout the community.

ARTICLE IV  
MEMBERSHIP

The doctrinal basis, manner of admission, and qualification of membership shall conform to the Church's Constitution and be regulated by its Bylaws, as may be amended from time to time.

ARTICLE V  
POWERS

This corporation shall have the power to acquire and hold title in fee simple, in trust, or otherwise, to both real and personal property and to improve, encumber, sell, convey, dispose of all such property; to borrow money, execute notes, bonds, and other evidences of indebtedness and secure the same by mortgage and deeds of trust, annuity bonds and other instruments of indebtedness and pay interest thereon; to improve, adapt and use its property or the income thereof in its religious, educational, benevolent, or social activities without financial profit to its members, except

as may be necessary in the payment of salaries and other compensation for services rendered, to erect and maintain buildings for the worship of God, for training in Christian faith and conduct and for Christian social intercourse, and to acquire or build and maintain residences for the use and occupancy of its ministers. Notwithstanding the specific powers enumerated above, the corporation shall have all powers available to a corporation not for profit under the laws of the State of Florida not inconsistent with the purpose of the corporation.

**ARTICLE VII**  
**OFFICERS**

(1) The officers of the corporation shall be a Pastor and President, Clerk, Treasurer, and Financial Secretary, as well as such other officers and assistant officers as may be appointed by the Board of Trustees from time to time in accordance with the Bylaws.

**ARTICLE VIII**  
**EXECUTIVE BOARD**

The business affairs of the corporation, including the maintenance of building and grounds, shall be managed by the Executive Board which shall consist of the Pastor and President, Clerk, Treasurer, Financial Secretary and such other Church members as elected from time to time and in accordance with the Bylaws. ARTICLE IX  
CONSTITUTION AND BYLAWS

The Constitution and Bylaws of the corporation shall be adopted by the complete Church body and may be altered or amended by two-thirds vote of the members present at any business meeting of the corporation.

The Constitution and Bylaws shall include the discipline of the Baptist Church Covenants as outlined in Article V of the Church's Constitution.

ARTICLE X  
AMENDMENTS

Amendments to the Articles of Incorporation may be proposed at any meeting of the Board of Trustees and adopted by two-thirds vote of members present at any business meeting of the corporation.

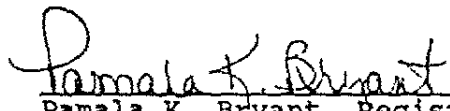
ARTICLE XI

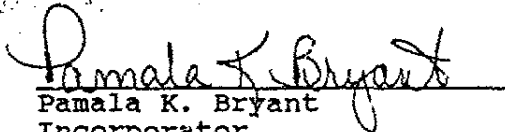

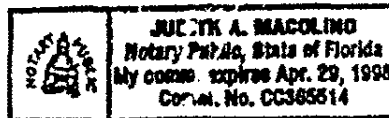
