To the Secretary of State.  
Ladies & Gentlemen.

The Associations Insurance Agent very recently (it's Policy renewal time) alerted us to the fact that our Status was listed as being "INACTIVE". This was a big surprise to this Association, because we always comply with all State and County requirements rather promptly.

A check into this matter revealed that the Association did not receive any Report Request Forms from your office after 8-16-2002 which is the last valid "File Date", nor did we receive any notification from your Department about "INACTIVE" effective Date: "NONE" - and no word whatsoever about Last Event: "ADMIN DISSOLUTION FOR ANNUAL REPORT" dated 09-11-2001, which strangely enough was 10 month prior the last recorded valid "File Date" according to the info posted on your Department Website for Document # N94000003525.

We also like to note that the Department of State has altered our Address, perhaps inadvertently, by writing "BOX 100" but it should be "# 100" it always was! Unfortunately you're not alone in doing so, County Offices, Health Department, Insurances, our Bank and numerous Contractors do make the same mistake from time to time despite the fact that they have the correct address in their files.

Whatever, the fact still is we do not have a "BOX or P.O. BOX ". Our Address always was as shown in the letterhead above! It seems to me this is a case of notification interruption (or breakdown) and the altered address may have something to do with it? Who knows?

Conclusion: Under these circumstances this Association believes it would be extremely unfair to penalize this Corporation for something, which was completely beyond its control. We politely request to be reinstated effective right now and that all fees be waived.
