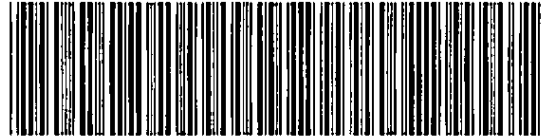

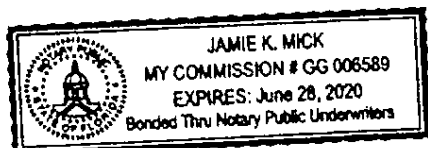

**ARTICLES OF AMENDMENT TO THE AMENDED AND RESTATED ARTICLES  
OF INCORPORATION OF NATURA HOMEOWNERS ASSOCIATION, INC.**

1. **Adopted amendment to ARTICLE VI of the Amended and Restated Articles of Incorporation of Natura Homeowners Association, Inc. (the "Articles"), to read as follows:**

**ARTICLE VI – BOARD OF DIRECTORS**

The affairs of this Association shall be managed by a Board of Directors, which ~~so long as Class B membership exists,~~ shall consist of three (3) directors, and thereafter shall consist of not less than three (3) nor more than nine (9) directors....

...  
The initial Board of Directors herein designated shall serve until Class B membership has ceased and been converted to Class A membership and until the first annual membership meeting thereafter, at which time the members shall elect three (3) directors. Directors elected at the first such annual membership meeting and thereafter shall be elected and serve terms as provided for in the By-Laws for a period of one year, and until their successors have been duly elected and qualified. ~~So long as Class B membership shall exist, any member of the Board of Directors may be removed, with or without cause, but only by the Class B member, and any vacancies occurring on the Board of Directors shall only be filled by appointment by the Class B member.~~

2. **Adopted amendment to ARTICLE X.A(3) of the Articles, to read as follows:**

**ARTICLE X – AMENDMENT OF ARTICLES**

A. These Articles of Incorporation may be amended, from time to time, as follows:

...  
(3) Except as elsewhere provided, an amendment shall be adopted if approved ~~either:~~

(a) ~~—by not less than two thirds (2/3) of the entire membership of the Board of Directors and also by not less than fifty one (51) percent~~ a majority of the votes of the voting members duly qualified to vote; ~~or~~

(b) ~~—by not less than seventy five (75) percent of the vote of the voting members duly qualified to vote, regardless of approval of the Board of Directors.~~
