



AMENDMENT

AMENDED AND RESTATED ARTICLES OF INCORPORATION FOR SPANISH WELLS COMMUNITY ASSOCIATION, INC.

Amendment No. 1.: Article 11, Section 11.01, Amended and Restated Articles of Incorporation

ARTICLE 11 AMENDMENT

11.01. These Articles of Incorporation may be amended at any time by the affirmative vote of two thirds (2/3rds) of the total number of Directors a majority vote of the voting interests (one voting interest per Lot or Unit) present (in person or by proxy) and voting at a duly called meeting of the Association.
