AMENDMENT TO THE ARTICLES OF INCORPORATION OF, SECOND BRIDGE BUILDERS INTERNATIONAL, INC.

Pursuant to Section 617.1002, Florida Statutes, the Articles of Incorporation of BRIDGE BUILDERS INTERNATIONAL, INC. (the "Corporation"), are hereby amended as follows:

FIRST: Article III of the Corporation's Articles of Incorporation is hereby deleted in its entirety, and the following is substituted in lieu thereof:
