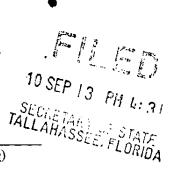

ARTICLE V - Limitations

At all times the following shall be conditions on the operations of the corporation:

- 1. The corporation shall operate for the benefit of no private interests and no part of its revenue shall inure to the personal and/or private benefit of any members, employees, officers, and/or directors of the corporation except for:
- (a) reasonable compensation or allowance for services actually rendered to the corporation; and/or
- (b) reimbursement for authorized and reasonable expenditures on behalf of the corporation;
- 2. All properties of the corporation shall be held in the name of the corporation and not in the name of any individual and shall be irrevocably devoted to the activities of the corporation and not to any personal and private benefits;
- 3. No substantial part of the activities of the corporation shall constitute carrying on political activities.
