PREAMBLE

We, whose names appear upon the Articles of Incorporation in order to establish and maintain a place for worship of Almighty God, our Heavenly Father, do hereby recognize ourselves as a sovereign local church. We desire to provide for Christian fellowship of those of like precious faith where the Holy Spint may be harmed according to our distinctive testimony to assume our share of responsibility and the privilege of propagating the gospet of Jesus Christ by all availables means, both at home and in foreign lands, and for this purpose we do adopt the following articles of church order and supmit ourselves to be governed by them.

ARTICLE I: CORPORATION NAME

The name of the corporation shall be NEW DISCIPLES' OF TREACH MINISTRY Find.

The principle address of the corporation is Post Office Box 638. Defray Beach Florida 33447, 3638.

ARTICLE II: CORPORATE EXISTENCE

This corporation shall have perpetual existence. While maintaining its innerent right to sovereignty in the conduct of its own affairs, this corporation (also known as "church") shall voluntarily enter into spiritual fellowship with all churches of like precious faith.

ARTICLE III PURPOSE AND VISION

Section 1 General Purposes

The general purpose of this corporation is to implement its New Testament commission by these prerogatives. (a) To administer the regular ordinances defined in the Bylaws, (b) To establish and maintain such departments, institutions, and services within the church for the nurposes of this corporation (c) To examine candidates for the ministry, and to license and ordain those who shall have been approved by the Pastor and Official "Ruling" Elders of this church according to the standards set forth by the New Testament. (d) To examine candidates and appoint missionaries and to endorse and support missionary programs according to the standards set forth by the New Testament, (e) To aggressively evangelize the world and establish and maintain religious worship to build and maintain churches, parsonages, schools hospita's hapels, and such other religious, educational and benevolent institutions as may be necessary or proper. (f) To maintain missionary undertakings in the United States or in any other foreign country, and to perform all other acts according to standards set forth by the New restament and as provided by and permitted under the laws of the state of Florida, to accomplish the general purpose and objective, (g) To designate its own officers, to appoint committees, to arrange for its own meetings, and to govern itself in accordance with the Bylaws (h) To establish and define policy by which it shall be governed.

Section 2. Internal Revenue Service.

Not withstanding any other provisions of these Articles, this organization shall not carry on any activities not permitted to the carried on by an organization exempt from Federal Income Tax under section 501 (c) (3) on the Internal Revenue Code of 1986 or the corresponding provisions of any future United States is ternal Revenue Law.

ARTICLE IV: MEMBERSHIP

Members of the corporation will be required to meet the following qualifications, to wit. To accept and agree to submit to, (1) the purposes of this corporation as set out in the Articles of Incorporation. (2) the Tenets of Faith as set forth in the Bylaws. (3) the requirements for membership as set out and regulated by the Bylaws which may be herein and/or hereafter imended.

Persons meeting such qualifications will be admitted by approval by the Board of Directors provided however, that neither members nor directors of the corporation shall have any vested rights interests, or privileges of in or to the assets, functions, affairs or franchises of this corporation, or any rights, interest, or privilege which may be inheritable or which shall continue after his membership ceases in the aforenamed corporation.

ARTICLE V. CORPORATE BOARD OF DIRECTORS

Section 1 Corporate Board Of Directors

The temporal and spiritual government of this church shall be vested in the Board of Directors which shall manage the affairs and property of the corporation. The Board of Directors shall be a self-perpetuating Board responsible for the replacement and the election of new members to the Board in accordance to this Article and those as regulated by the Bylaws.

The corporation shall have a minimum number of four (4) members and a r. xximum number of twelve (12) members of the Board of Directors. The manner of admission, qualifications, discipline and dismissal of members of the Board of Directors shall be regulated by the Bylaws. Section 2. Corporate Officers

The Board of Directors shall constitute and elect the following officers as regulated by the Bylaws (1) the President of the corporation (2) the Vice-President(s₁, (3) the Secretary, (4) the Treasurer (5) and such other officers of which shall be provided for as regulated by the Bylaws

Section 3 Corporate Annual Meeting

The Board of Directors shall call an Annual Progress Report of the church, to be held in the first quarter of the calendar year, at which time reports of all efficers shall be presented and election of the Board shall take place.

Due notice of the Annual Progress Report shall be given to the church at the morning worship service on the two Sundays immediately preceding the scheduled date of the meeting

ARTICLE VI: CURPORATE STOCK

This corporation is organized under a non-stock basis

ARTICLE VII: DISSOLUTION OF CORPORATE ASSETS

in the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations de-cribed in Section 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954 or corresponding Sections of any prior or future law, or to the federal, state, or local government for exclusive public purpose.

ARTICLE VIII: AMENDMENTS

The Articles of Incorporation and the Bylaws of the Corporation may be made, altered, or rescinded by an absolute unanimous vote of the Board of Directors of the Corporation at any regular or special meeting called for that purpose provided notice of such proposed change shall have been made at the morning worship services on at least two Sundays preceding the time of such meeting of the Board, and provided a copy of such proposed change shall have been mailed to each member of the Board at least two weeks.
