ARTICLES OF INCORPORATION OF SPRINGING THE BLUES SOCIETY, INC.

The undersigned, acting as incorporator for the purpose of forming a Not For Profit Corporation, pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be: Springing the Blues Society, Inc.

ARTICLE II - PRINCIPAL PLACE AND MAILING ADDRESS

The principal place of business shall be 209 South Third Street, Jacksonville Beach, FL 32250 and the mailing address shall be P.O. Box 51348, Jacksonville Beach, Florida 32250.

ARTICLE III - PURPOSES

The specific purposes for which the corporation is organized are as follows:

- A. To educate, to preserve, and to perpetuate America's original indigenous musical art form known as the "Blues"; and
- B. To do such things and to perform such other civic acts to accomplish these purposes as the Board of Directors may determine to be appropriate and are consistent with the powers conferred on Not For Profit Corporations under the laws of the State of Florida.

ARTICLE IV - MANNER OF ELECTION OF DIFECTORS.

The manner in which the Board of Directors are elected or appointed shall be set forth in the Bylaws of the corporation. The initial Board of Directors shall have three (3) members whose names and addresses are:

The number of Directors may be raised or lowered by amendment of the bylaws but shall in no case be less than three.

ARTICLE V - LIMITATION OF CORPORATE POWERS

The Corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its Members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.
