ARTICLES OF INCORPORATION OF CEDD, INC.

ARTICLE I NAME OF CORPORATION

The name of the Corporation is CEDD, INC. This is a not-fore profit corporation organized under Chapter 617 of the Florida's Statutes.

ARTICLE II DURATION

The term of this Corporation is perpetual and the corporate existence will commence upon the filing of these λ rticles with the office of the Secretary of State.

ARTICLE III PURPOSE

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation is further organized to engage in lawful purpose or purposes not for pecuniary profit.

ARTICLE IV

There shall be three (3) members of the initial Board of the Corporation. The number of directors may be amended by by-laws but, in no event, shall there be less than three (3) directors. The manner in which the directors are elected shall be regulated by the By-Laws of the corporation. The names and addresses of the persons who are to serve as directors until the first election thereof, are as follows:

ARTICLE V PRINCIPAL and REGISTERED OFFICE

The principal and initial registered office of the Corporation shall be located at 2149 No. Smathers Circle, Melbourne, FL 32935.

ARTICLE VI REGISTERED AGENT

The initial registered agent of the Corporation shall be Fred Hartery, 2149 No. Smathers Circle, Melbourne, FL 32935.

ARTICLE VII MEMBERS

The qualifications for members and the manner of their admission shall be regulated by the By-Laws of the Corporation.

ARTICLE VIII PROHIBITIVE ACTIONS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
