We, the undersigned, hereby associated ourselves together for the purpose of becoming a corporation not for profit under the Laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation not for profit

#### ARTICLE 1 NAME OF CORPORATION

The name of this corporation shall be MOUNT OLIVE PRIMITIVE CEMETERY, INC

### ARTICLE 2 GENERAL NATURE OF BUSINESS

The general nature of the business to be conducted by the corporation is operating and maintaining a cemetery provided there shall be no right to sell cemetery. Its as merchandise by the corporation. except for maintenance of the cemetery.

### ARTICLE 3 POWERS

The corporation shall have all the laws and statutory powers of a corporation not for profit and all of the powers and duties as set forth in the Bylaws.

# ARTICLE 4 MEMBERS

To become a member of this corporation you must be a permanent resident of the community and live within a 15 mile radius of the cemetery, or have a family member buried in the cemetery, and pay an initial fee as set by the Board of Directors of the Corporation.

# ARTICLE 5 INCOME DISTRIBUTION

No part of the income of this corporation shall be distributed to its members, except as compensation for services rendered

#### ARTICLE 6 EXISTENCE

This corporation shall exist perpetually unless dissolved according to law

### ARTICLE 7 REGISTERED OFFICE AND REGISTERED AGENT
