## ARTICLES OF INCORPORATION

OF

WINTER GARDEN LODGE NUMBER 2165 OF THE BENEVOLENT AND PROTECTIVE ORDER OF ELKS OF THE UNITED STATES OF AMERICA, INCORPORATED.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this date voluntarily associated ourselves together for the purpose of forming a non-profit corporation under the laws of the State of Florida, and we hereby certify:

## ARTICLE I - NAME

The name of this Corporation Not For Profit shall be WINTER GARDEN LODGE NUMBER 2165 OF THE BENEVOLENT AND PROTECTIVE ORDER OF ELKS OF THE UNITED STATES OF AMERICA, INCORPORATED.

#### ARTICLE II - PURPOSE

The purposes for which said Corporation is formed are:

- 1. The primary purpose for which this Corporation is formed is to inculcate the principles of Charity, Justice, Brotherly Love and Fidelity; to promote the welfare and enhance the happiness of it's members; to quicken the spirit of American patriotism; to cultivate good fellowship and to perpetuate itself as a fraternal organization.
- 2. Other purposes for which this Corporation is formed are: to do all the acts and things and business and businesses in any manner connected with the objects of purposes or powers of the Corporation or necessary, incidental, convenient or auxiliary thereto, calculated directly or indi-rectly to promote the interests, objectives and ideals of the organization and, in addition, to have and exercise all rights, powers and privileges now or hereafter belonging to or conferred upon non-profit corporations existing under the laws of the State of Florida.
- 3. The foregoing statement of purpose or purposes shall be construed as a statement of both purpose and powers and the purposes and powers in each clause shall, except where otherwise expressed, be in nowise limited or restricted by reference to or inference from the terms or provisions of any other clause but shall be regarded as independent purposes and powers.

## ARTICLE III - ORGANIZED AS A FRATERNAL ORGANIZATION

This Corporation is organized exclusively as a fraternal organization and as a non-profit corporation and it's activities shall be conducted for the aforesaid purposes in such manner that no part of it's net earnings will inure to the benefit of any member, director, Trustee, Officer of other individual.

#### ARTICLE IV - FLORIDA CORPORATION NOT FOR PROFIT

This Corporation is organized pursuant to the General Laws of the State of Florida as pertains to Florida Corporations Not For Profit.

ARTICLE V - REGISTERED OFFICE and REGISTERED AGENT

AND PRINCIPAL

The Registered Office of the Corporation shall be located at 700 South 9th Street, Winter Garden, Orange County, Florida 34787 and the name of the initial Registered Agent for service of process at said address shall be Bill Scarborough, President.

## ARTICLE VI - OFFICERS and DIRECTORS

- The Officers, Directors and Trustees of this Corporation, their nomination, election or appointment, installation, power and authority shall be in accordance with the provisions setforth in the By-Laws of this Corporation.
- The governing body of this corporation shall be it's Board of Directors which shall consist of the following Officers of the Corporation: EXALTED RULER, ESTEEMED LEADING KNIGHT, ESTEEMED LOYAL KNIGHT, ESTEEMED LECTURING KNIGHT and 5 persons who shall bear the title of Trustee.
- The names and addresses of the persons who are to act in the capacity of directors of this Corporation until the selection of their successors are as set forth herein below.

#### ARTICLE VII - BY-LAWS

The By-Laws of said Corporation shall define the duties of the Directors, Officers and Trustees of the Corporation; that the manner of election and term of office of the Directors, Officers and Trustees of the Corporation shall be as set forth in the By-Laws of the Corporation; that the number of persons to serve in the capacity of Directors may be changed from time to time by the By-Laws of said Corporation and that said Corporation is hereby granted authority to make a Code of By-Laws for it's government and to amend the same from time to time as provided in said By-Laws.

#### ARTICLE VIII - GRAND LODGE CONSTITUTION AND STATUTES

The term of existance of this corporation shall be perpetual from the date it's Charter is Issued by the State of Florida, Department of State.
