Articles of Incorporation
of
Orange Park Baptist Church, Inc.

We, the undersigned, being desirous of forming a corporation, not for profit, for religious and charitable purposes, under the provisions of Chapter 617, Florida Statutes, do hereby propose and subscribe the following Charter:

ARTICLE I

The name of the Corporation shall be:
Orange Park Baptist Church, Inc.

ARTICLE II

The street address of the initial principle office and mailing address of this Corporation shall be:

ARTICLE III

The general nature and the objects of the corporation shall be religious, charitable, and such other, as are generally carried on by Baptist Churches of the United States; to organize, maintain, operate and conduct such Churches, departments or agencies, so as to carry out the above mentioned purposes; to own, control, lease, purchase or take by gift, devise, bequest or otherwise, and to convey, dispose, encumber, lease and to do all things and exercise all powers which a natural person might do and exercise control over real and personal property of every nature and kind whatsoever.

ARTICLE IV

The method of election of directors shall be stated in the Corporation's Bylaws.

ARTICLE V

The corporation shall exist perpetually.

Notwithstanding any other provisions of these articles, the purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and education within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

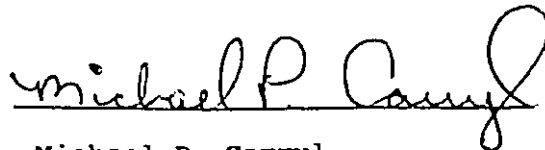
At the June 9, 1996 Orange Park Baptist Church Elders meeting the following two resolutions were unanimously approved.
