The undersigned, acting as incorporator of this Nonprofit Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of this Nonprofit Corporation is Behold, The Bridegroom Cometh, Inc.

ARTICLE II. AFFILIATION

This Nonprofit Corporation is a subordinate ~~member of Kingsway~~ Ministries, Inc. a/k/a Kingsway Fellowship International and is pledged to promote and fulfill its purposes.

ARTICLE III. PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office is 2190 N.E. 51 Court, No. 205, Ft. Lauderdale, Florida 33308. The initial mailing address of this Nonprofit Corporation is 2190 N.E. 51 Court, No. 205, Ft. Lauderdale, Florida 33308.

ARTICLE IV. INITIAL REGISTERED AGENT AND STREET ADDRESS

The initial registered agent is Rev. Sherry Rosenfeld.

ARTICLE V. PURPOSE

The purpose of this corporation is the propagation and dissemination of the Gospel of the Lord Jesus Christ, through the preaching of salvation through Jesus Christ, the teaching of both the Old and New Testaments, and the empowerment of the Holy Spirit as outlined in the Articles of Faith of Behold, The Bridegroom Cometh, Inc.

To accomplish such purpose the Corporation may, among other means; assist in and/or establish religious schools, and colleges,

children's homes, and centers of hospitality; take active part in short and/or long term mission work; hold evangelistic meetings, provide Bible teaching from both the Old and New Testaments, and distribute biblically based materials; and ultimately be engaged in all types of religious and charitable activities including Bible teaching and evangelism through the distribution of printed material, electronic broadcasting, A.M. and F.M. radio, cable and satellite television, and any other related projects for the carrying out of these ministries.

ARTICLE VI. LIMITATION OF CORPORATE POWERS

The corporate powers of this Nonprofit Corporation are as provided in section 617.0302 Florida Statutes, unless limited as follows:

This corporation is organized and operated exclusively for religious purposes, no part of the net earnings shall inure to the benefit of any private individual, No substantial part of the activities shall consist of the carrying on of propaganda, or otherwise attempting to influence legislation, the participation in, intervention in the publication of in the publication of distribution of statements of any political campaign on behalf of any candidate for public office. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the corporation shall inure to the benefit of any private individual; but the corporation shall be authorized and empowered to pay reasonable compensation for services rendered, and to make payments and distributions in furtherance of its stated purposes, including the right of this corporation to possess, buy, mortgage, sell, barter and exchange real personal property, to borrow money, collect funds, receive gifts and legacies as it may judge necessary for the attainment of these purposes.

ARTICLE VII. INCORPORATOR

ARTICLE VIII. MANNER OF ELECTION OR APPOINTMENT OF BOARD OF DIRECTORS

The manner in which the Board of Directors are elected or appointed

is as follows:

The Board of Directors shall be appointed by the Incorporator of this Nonprofit Corporation. The number of directors may be raised or lowered by amendment of the Bylaws but shall in no case be less than three.

ARTICLE IX. OFFICERS

The officers of the Corporation shall consist of a President, Vice President, Secretary/Treasurer. Other officers may be provided for in the Bylaws. Each officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) as such time and in such manner as may be prescribed by the Bylaws.

ARTICLE X. MEETINGS

The annual meeting and special meetings of the Corporation shall be held at such times as stated in the Constitution and Bylaws.

ARTICLE XI. PROPERTY

Section 1. Documents relating to the conveying or encumbering real state shall be signed by the President and one other Board Member, specifically the office holder of Treasurer.

Section 2. All property of this Corporation should be recorded in the name of the Corporation. In the event of a defection of any members of this corporation from its Articles of Faith, or from affiliation with Behold, The Bridegroom Cometh, Inc., the title of all Corporation property, real or personal, shall remain with those members abiding by such Articles of Faith and retaining affiliation with Behold, The Bridegroom Cometh, Inc.

ARTICLE XII. DISSOLUTION

In the event of dissolution of this Nonprofit Corporation, all its property shall pass to an organization as determined by the Board of Directors of this Corporation whose purpose is in harmony with the full gospel message as outlined in this corporation's Articles of Faith. Such organization must be organized and operated exclusively for the purposes specified in Section 501 (c) (3) of the International Revenue Code.

ARTICLE XIII. AMENDMENTS

These articles may be amended by a simple majority vote of the Board of Directors present at a duly called meeting where all Board

members are notified in written form a minimum of ten days prior to the meeting. The President must be present at this meeting.
