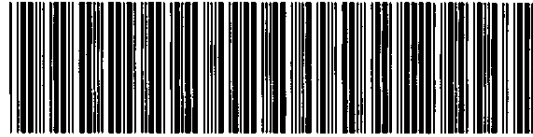

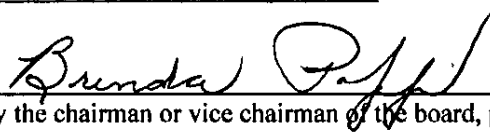

Amendment to Article III: Purpose

The specific and primary purpose for which this Corporation is organized and the general nature of the aims and objectives of the Corporation are to demonstrate the Gospel of Christ in word and action; and to affect the church's members towards living a life in accord with Christ's Gospel; to promote the advancement and glory of Christ's Kingdom by evangelism, charitable works, social services and by fostering affordable housing; and to take and hold property for the application thereof, to the foregoing purposes. The Corporation will be a social service agency ~~and a child caring agency~~ providing for the material, emotional and spiritual needs of individuals, families, and children and will initiate programs and services designed to build up the whole body of Christ's church in faith, hope and charity through the incorporation of unconditional love in those programs and services.

Notwithstanding any other provision of these Articles, this Corporation will not carry on any other activities not permitted to be carried on by 1) a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law, or 2) a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code of 1986 or any other corresponding provision of any future United States Internal Revenue law.
