CHARTER

We, the undersigned, hereby organize for the purpose of becoming incorporated under Chapter 617 of the Florida Statutes applicable to Corporations, not for profit, and respectively petition the Secretary of State for approval of incorporation:

ARTICLE I

The name of this organization shall be the Concerned Alachua Citizens, Inc., here after, referred to as CAC.

ARTICLE II

CAC shall encourage citizens participation in the city and county governmental processes relative to community improvements.

Encourage citizens awareness of available resources in the city and county to promote adequate housing, new businesses and new industries, hopefully, which will enhance the economic base of the community.

CAC shall work with the Department of Police and Fire for better protection for the citizens in the area.

CAC will serve as resource to the community and through its Board of Directors shall be responsible for decisions, which are necessary for administration and supervision of the organization.

ARTICLE III

Any adult person living in the area, regardless of race, sex, religion, or national origin is eligible for membership in the organization.

Membership dues are assessed annually.

ARTICLE IV

The officers of the organization shall be; President, Vice-President, Secretary, Assistant Secretary, Treasures, Business Manager and Parliamentarian.

The Board shall be responsible for establishing policy and operations of CAC and compliance to the by-laws. The method of election for directors is to be voted upon by popular two thirds vote, further references will be noted in Bylaws.

CAC shall appoint various committees to deal with important matters as the need arises.

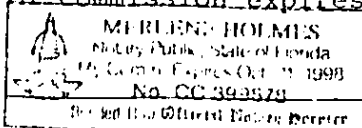
