ARTICLES OF INCORPORATION OF

Body of Christ Church of Broward County A FLORIDA NONPROFIT CORPORATION

ARTICLE ONE — The name of the corporation is Body of Christ Church of Broward County Inc.

ARTICLE TWO — The period of its duration is perpetual.

ARTICLE THREE — The purpose for which the corporation is organized is as follows:

A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of this corporation is to conduct all activities necessary for religious worship of the members of this corporation;

B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

ARTICLE FOUR — The Corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and privileges of members of the Corporation. The Bylaws may provide for Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws, but who shall not have the right to vote. ARTICLE FIVE — The street address of its initial registered office is 1400 E. Oakland Park Blvd., Fort Lauderdale, Florida, and the name of its initial registered agent at such address is John M. House. The address of its principal office is the same as its initial registered office.

ARTICLE SIX — The number of directors constituting the initial board of directors is three, and the names and addresses of the persons who are to serve as directors are:

The number of directors may be raised or lowered by amendment of the bylaws but in no case shall be less than three.

ARTICLE SEVEN — The officers of the Corporation shall consist of a President, Secretary, and Treasurer. Other officers may be provided for in the Bylaws. Each Officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time and in such manner as may be prescribed by the Bylaws.
