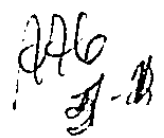

We, the undersigned persons of the State of Florida, all of whom are of legal age, each being competent to contract, heroby form ourselves and our successors into a corporation not for profit under the Laws of the State of Florida, and heroby adopt the following Articles of Incorporation.

ARTICLES I- NAME

The name of this Corporation shall be: SAMARIA EVANGELICAL CHURCH, INC. with its principal place of business located at 1320 W. Bryan Street Kissimmee, Florida 34741. The name of this corporation initial registered agent and his address is:

ARTICLES II- TERMS OF EXISTENCE

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation within the Department of State.

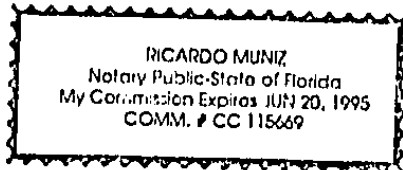
