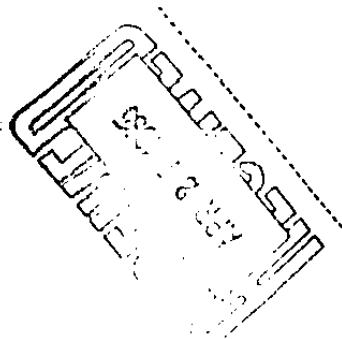

THE UNDERSIGNED, has executed the following document as incorporator of the above named corporation, a corporation organized under the laws of the State of Florida, and all rights, duties and obligations of the undersigned as incorporator, and those of the corporation, are to be determined in accordance with the laws of the State of Florida.

ARTICLE I

The name of the corporation is TNT EVANGELISTIC ASSOCIATION, INC.

ARTICLE II

This corporation shall commence existence upon the filing of these Articles of Incorporation by the Department of State, State of Florida, and shall have perpetual existence.

ARTICLE III

This is a non-profit corporation, organized solely for general religious, charitable and educational purposes pursuant to the Florida Corporations Not For Profit Law set forth in Section 617 of the Florida Statutes, and as amended.

The specific and primary purposes of which this corporation is formed shall be:

1. To foster, promote and perpetuate the Christian faith according to the Holy Scripture through evangelistic ministry.

2. To operate exclusively in any other manner for such religious, charitable and educational purpose as will qualify it as

an exempt organization under the Internal Revenue Code, as amended, or under any corresponding provisions of any subsequent federal tax laws, covering the distribution to organizations qualified as tax exempt organizations under the Internal Revenue Code, including private foundations and private operating foundations.

#### ARTICLE IV

For the purpose of promoting the foregoing general and specific purposes, this corporation shall have the right or power to:

(a) acquire, either by gift or purchase, and to hold, own, sell, mortgage, or encumber in any manner, lease or improve, real and personal property, for itself and others, either as Trustee or otherwise;

(b) to sue and be sued, to make and use a common seal, which may be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed, or in any other manner reproduced;

(c) to execute deeds and mortgages, bills of sale, leases, agreements, and such other written instruments as may be necessary to carry out said power and authority, and to further the said objects and purposes of the corporation;

(d) to make By-Laws not inconsistent or contrary to its Articles of Incorporation, or with the laws of the State of Florida for the regulation of its affairs and the management of its property, the same to be subject to amendment when desirable, pursuant to the methods therein provided;

(e) to conduct its business, carry on its operations, and

have offices and exercise the powers granted by this action within or without this state;

(f) to elect or appoint officers and agents of the corporation and define their duties and fix their compensation;

(g) to make donations for the public welfare or for charitable, scientific, or educational purposes;

(h) to transact any lawful business which the Board of Directors shall find will be in aid of governmental policy.

#### ARTICLE V

This corporation is organized under a non-stock basis.

#### ARTICLE VI

All revenue, profit, income and money received from the conduct of this corporation is to be used and employed in religious, educational, charitable, or benevolent work, and not for the benefit of the members of said corporation, either individually or collectively, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.

#### ARTICLE VII

The street address of the initial registered office and the name of the initial Registered Agent of this corporation shall be: Ronnie Lee Wallace, 110 NW 207 Way, Pembroke Pines, FL 33029.

#### ARTICLE VIII

The initial Board of Directors shall consist of a total of three persons and the names and addresses of the persons who are to

serve as initial directors are:

The members of the initial Board of Directors shall hold office until the first annual meeting of the Board of Directors of the corporation at which time in accordance with the By-Laws, the corporation may elect a new Board of Directors.

The number of directors may be altered from time to time by the By-Laws adopted by the corporation. However, the corporation shall have no less than three directors at any time.

corresponding sections of any prior or future law, or to the Federal, State, or Local Government for exclusive public purpose.

ARTICLE XII

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the trustees is subject to this reservation.



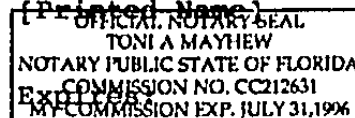


