The undersigned hereby organizes a corporation, not for profit, under the provisions of the Florida General Corporation Act, and pursuant to the following Articles of Incorporation.

ARTICLE I: NAME

The name of this corporation is:

FREEDOM FIGHTERS' MINISTRIES, INC.

ARTICLE II: PRINCIPAL OFFICE

The address of the principal office of this Corporation is 1913 Dockside Drive, Valrico, Florida 33594.

ARTICLE III: PURPOSE

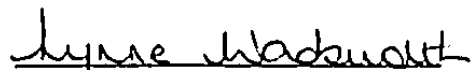

Pursuant to the provision of Chapter 617, Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: The name of the corporation is Freedom Fighters' Ministries, Inc.

SECOND: The following amendments to the articles of incorporation were adopted by the corporation:

Amendment to Article III - add following language to existing article:

The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Revenue law.

Amendment to Article XI - add following language to existing article:

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Revenue law.

THIRD: The amendments were adopted by the Board of Directors on the 15th day of November, 1995.

FOURTH: The above amendments were approved by a majority of the members of the corporation entitled to vote thereon on the 15th day of November, 1995. The number of votes cast was sufficient for approval.
