**Articles of Incorporation  
of  
The Tallahassee Tiger Sharks Booster Club, Incorporated**

The undersigned, acting as incorporators of a corporation under the Florida Not For Profit Corporation Act, adopt the following Articles of Incorporation for such corporation.

**Article I - Name**

The name of the corporation is The Tallahassee Tiger Sharks Booster Club, Incorporated.

**Article II - Term of Existence**

The period of duration of this corporation is perpetual.

**Article III- Nature of Corporation**

The corporation shall act as a booster organization for the purpose of supporting hockey in Tallahassee, Florida, through the community's professional hockey franchise.

**Article IV - Selection of Board Members**

Members of the Board of Directors, including officers, shall be chosen as provided by the bylaws.

**Article V - Registered Office and Agent**

The street address of the initial registered office of the corporation is 2799 A. J. Henry Park Drive, Tallahassee, Florida 32308. The mailing address is P. O. Box 3812, Tallahassee, Florida 32315. The name of its initial registered agent at such address is Allen K. Nobles.

**Article VI - Number of Directors**

The number of directors constituting the initial Board of Directors is nine. The names and addresses of such persons who shall serve as members of the initial board, until their successors are duly selected in accordance with the bylaws, are as set out in Appendix A to these articles.

**Article VII - Incorporators**

The name and address of each incorporator is as set out in Appendix B to these articles.

**Article VIII - Corporate Governance**

All corporate actions, including, but not limited to, organization membership, voting privileges and restrictions, dues, meetings, programs, and activities, shall be as provided by the bylaws.

**Article IX - Amendments**

The Board of Directors shall have the power to adopt, amend, alter, change or repeal the Articles of Incorporation and bylaws by a two-thirds (2/3) vote at a duly called meeting following timely notice as set out in the bylaws.
