The undersigned, wishing from a religious corporation, have caused to be prepared, executed, and subscribed a Charter pursuant to Section 617.01, 1961 Florida Statutes, provided for in and by said Section.

ARTICLE I

NAME AND LOCATION

The name of the Corporation shall be the ST. PETERS APOSTOLIC CHURCH, INC., and the place where it is to be located shall be Hillsborough County, Florida.

ARTICLE II

GENERAL NATURE AND OBJECT OF CORPORATION

The general nature and object of the Corporation shall be (1) To establish and maintain churches, missions, and other places of worship according to the Old and New Testaments, and (2) To teach and to ordain ministers in accordance with the teachings of the Old and New Testaments, and (3) To do and perform any and all matters and things customary within the scope of religious corporations based upon Christian Faith in accordance with the Old and New Testaments.

ARTICLE III

ELIGIBILITY FOR MEMBERSHIP

1. A member in good standing of one of the Churches of this Corporation shall automatically become a member of the Corporation upon certification of such membership to the Trustee's Board of this Corporation by the Secretary of such Church. (2) For membership to a Church of this Corporation, a person shall be of good moral character, shall have had a definite experience in salvation according to the New Testament, and shall be a firm believer in the teachings of the Old and New Testaments. and (3) A member of this Corporation may be expelled by the General Trustees of this Corporation if it shall determine upon hearing that such member no longer possesses the qualifications required of him for admission, or if such member shall commit an act or acts detrimental to the best interest and welfare of this Corporation. Upon expulsion by action of the General Trustee Board, such expelled member shall automatically become expelled from membership with the Church of this Corporation, within thirty days from

the date of such expulsion, a member expelled by the General Trustees Board may appeal to the convention by filing Notice of appeal with the Secretary of this Corporation. Provided, however, that nothing herein contained shall be construed as taking away from a church the right to expel a member for cause upon hearing with the right on the part of such member to an appeal to the General Trustees Board of this corporation.

ARTICLE IV

QUARTERS

The term for which this corporation shall exist shall be indefinite.

ARTICLE V

ARTICLE VI

All business shall be transacted by the General Trustees, with the Bishop serving as Chairman of the Trustee Board. All Trustees shall be elected at the first Semi-Annual meeting during the month of November, 1958, and all Trustees then elected shall serve for life. A Trustee may be removed for disciplinary conduct, such removal may be by vote of the General Trustee Board at a Special meeting called by the Bishop or any Annual or Semi-Annual meeting. In the event of death, of a Trustee the Bishop may appoint a Trustee until the next Annual or Semi-Annual meeting at which time the delegates would approve the Bishop's appointment or disapproval. The

Bishop also have the authority to relieve a Trustee whose usefulness to the organization has become impaired, such release shall be without recourse and in the sole discretion of the Bishop.

ARTICLE VII

INDEMNITY AND LIABILITY

The General Body can hold property up to \$250,000.00 and incur liability up to \$400,000.00. All subordinate churches can hold property up to \$50,000.00 and incur liabilities up to \$750.00.

ARTICLE VIII

ORDINATION

Shall be performed by District Superintendent or as a result of his appointment or by the Bishop.

ARTICLE IX

This Charter shall be binding upon Apostolic Faith of Churches in any State in the United States. When such church has been organized and accepted at the Annual Convention of this Corporation, and upon filing a certified copy of this Charter with the proper State official of the accepted Church.
