STATEMENT OF FACTS

I, Margaret Murdock, an active member of the Board of Trustees of St. Peter's Apostolic Church, Inc., (the "Corporation" or "Church") the headquarters of which is situated at 3303 E. Ellicott Street, Tampa, Florida 33610, hereby declare the following in relation to the Church:

In the Annual Report filed with the Secretary of State of Florida, Division of Corporations on April 4, 2024, there are several errors that need to be corrected.

According to Article VI of the Constitution and Bylaws of the said Corporation trustees can be appointed at special meetings of the Board of Trustee or at regular semi-annual or annual meetings of the Board. Since there is no presiding Bishop no special meetings can be properly called and no notice of semi-annual or annual meetings has been provided, not minutes or consent resolutions of semi-annual or annual meetings have been produced, and therefore no validly constituted semi-annual or annual meetings have been held to appoint new board members, the nomination and appointment of the following trustees is invalid and the Annual Return of April 4, 2024, Document Number N95000002958, should be corrected by removing the designation of trustee for each of the following:

- Pastor Damian Bryant – Trustee, Chairman
- Kenya Bryant (Pastor Bryant's Wife) – Trustee, executive secretary
- Jacquelyn Hanson (Pastor Bryant's Mother) – Trustee
- Fredrick Ford – Trustee

In addition, the Annual Report of April 4, 2024, improperly describes trustee Margaret Murdock as an "inactive" member of the Board of Trustees. Mrs. Murdock is an active member of the Board of Trustees, therefore the word "inactive" must be removed from the Annual Report.

The Annual Report of April 4, 2024 contains an erroneous address for the Church's principal address. The correct address is 3303 E. Ellicott Street, Tampa, Florida 33610.

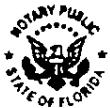
