AMENDMENT II TO ARTICLES OF INCORPORATION
THE WHOLE WORD CHRISTIAN ACADEMY, INC.

These Articles of Incorporation for the Whole Word Christian Academy, Inc. are hereby amended as follows:

ARTICLE III


Paragraph three of Article III is hereby amended to read as follows:

Upon the dissolution of the organization, assets shall be distributed for one or ore exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal Tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purpose.

All other provisions of the Articles of Incorporation shall remain unchanged.

This Amendment being adopted on the 25th day of November by 4 members as is sufficient for approval.
