WE, the undersigned, hereby associate ourselves together for the purpose of forming a non-profit corporation under the laws of the State of Florida pursuant to Florida Statutes 617, Et Seq., and hereby certify as follows:

ARTICLE I

The name of the corporation shall be THE SHAMROCK CONDOMINIUM ASSOCIATION, INC.

ARTICLE II

The general purpose of this non-profit corporation shall be as follows: To be the "Condominium Association" (as defined in the Condominium Act of the State of Florida, F.S. 718, Et Seq.) for the operation of THE SHAMROCK CONDOMINIUM to be created pursuant to the provisions of the Condominium Act, and as such Condominium Association to operate and administer said Condominium and carry out the functions and duties of said Condominium Association as set forth in the Declaration of Condominium establishing said Condominium and Exhibits annexed thereto.

at a duly convened special meeting of the membership attended by a majority of the membership, by vote, as follows:

- A. If the proposed change has been approved by the unanimous approval of the Board, then it shall require only a majority of the total membership to be adopted.
- B. If the proposed change has not been approved by the unanimous vote of the Board, then the proposed change must be approved by three-fourths (3/4) of the total vote of the membership to be adopted.

Provided, however, that any changes to the size or configuration of units will require the unanimous consent of all unit owners. Also, provided, however, that any changes to the Declaration, By-Laws or equivalent documents of the Condominium, which establish, provide for, govern or regulate (1) voting; (2) assessments, assessment liens or subordination of such liens; (3) insurance or Fidelity Bonds; (4) rights to use of the common elements; (5) responsibility for maintenance and repair of the several portions of the Condominium; (6) expansion or contraction of the condominium regime or the addition, annexation or withdrawal of property to or from the regime; (7) the interests in the general or limited common elements; (8) convertability of units into common elements or of common elements into units; (9) leasing of units; (10) imposition

Also, provided, however, that any changes to the Declaration, By-Laws or equivalent documents of the Condominium, which materially affect the rights or interest of mortgagees, or where such consent is otherwise required by the Federal National Mortgage Association or Federal Home Loan Mortgage Corporation shall be subject to the approval of all first mortgagees having an interest on a unit(s), which approval may not be unreasonably withheld. Also, provided, however, that no amendment shall change the rights or privileges of Developer referred to in said Declaration and Exhibits attached thereto, without Developer's written approval.

#### ARTICLE X

Amendments to these Articles of Incorporation may be proposed by any member or director and shall be adopted in the same manner as is provided for the amendment of the By-Laws as set forth in Article IX above. Said amendment(s) shall be effective when a copy thereof, together with an attached certificate of its approval by

In the event there are any excess receipts over disbursements as a result of performing services, such excess shall be applied against future expenses, etc. The corporation may pay compensation in a reasonable amount to its members, directors and officers for services rendered, may confer benefits upon its members in conformity with its purposes and, upon dissolution or final liquidation, may make distribution to its members as is permitted by the Court having jurisdiction thereof, and no such payment, benefit or distribution shall be deemed to be a dividend or distribution of income.


