ARTICLES OF INCORPORATION

OF

NEW EIRTH BAPTIST CEURCH OF PENSACOLA, INC.

We, the undersigned interested Christians, do hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of this religious corporation is New Birth Baptist Church of Pensacola, Inc.

ARTICLE II - STATUS

This corporation is a non-profit religious corporation which shall function as a church and which is formed $b_{Y'}$ the undersigned who solemnly and joyfully enter into covenant with one another as one body in Jesus Christ.

ARTICLE III - PURPOSE

The purpose for which this corporation is organized shall be to function as a Christian unit in Christian love; to strive for the advancement of this church, in knowledge, holiness, and comfort; to promote its prosperity and spirituality; to sustain its worship, ordinances, discipline, and doctrines; to contribute cheerfully and regularly to the support of the ministry, the expenses of the church, the relief of the poor, and the spread of the gospel through all nations.
