**ARTICLES OF INCORPORATION
OF
NEW BIRTH BAPTIST CHURCH OF PENSACOLA, INC.**

We, the undersigned interested Christians, do hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of this religious corporation is New Birth Baptist Church of Pensacola, Inc.

ARTICLE II - STATUS

This corporation is a non-profit religious corporation which shall function as a church and which is formed by the undersigned who solemnly and joyfully enter into covenant with one another as one body in Jesus Christ.

ARTICLE III - PURPOSE

The purpose for which this corporation is organized shall be to function as a Christian unit in Christian love; to strive for the advancement of this church, in knowledge, holiness, and comfort; to promote its prosperity and spirituality; to sustain its worship, ordinances, discipline, and doctrines; to contribute cheerfully and regularly to the support of the ministry, the expenses of the church, the relief of the poor, and the spread of the gospel through all nations.

**ARTICLE IV - PLACE OF WORSHIP, OFFICE, REGISTERED
OFFICE, MAILING ADDRESS AND REGISTERED AGENT**

The address of the principal place of business, the initial registered office, the mailing address and the place of worship of this corporation is 1610 North "Q" Street, Pensacola,

Florida 32505. The name of the initial registered agent at that address is Charles Brown, whose signature hereto constitutes his agreement to serve as registered agent and to accept service of process for the above stated corporation at the place designated in this certificate, and constitutes his agreement to comply with the provisions of all statutes relative to the proper and complete performance of his duties, and his certification that he is familiar with and accepts the obligation of his position as registered agent.

ARTICLE V - DURATION

The period of duration of this corporation is perpetual for the sake of the public laws of the State of Florida, but the duration shall end meantime upon the second advent of Jesus Christ.

ARTICLE VI - NONSTOCK CORPORATION

This corporation shall be nonstock and no dividends or pecuniary profits shall be declared or paid to the members thereof. But we will engage to watch over each and every member in brotherly love; to remember one another in prayer; to aid one another in sickness and distress; to cultivate Christian sympathy in feeling and Christian courtesy in speech; to be slow to take offense, but always ready for reconciliation and mindful of the rules of our Savior to secure it without delay.

ARTICLE VII - TRUSTEES

The affairs of this corporation shall be governed by the Board of Trustees which shall consist of not less than one nor more than nine members, as established from time to time by the by-laws. The

i. itial Board of Trustees shall consist of nine members whose names and addresses are as follows:

ARTICLE VIII - ELECTION OF TRUSTEES

The trustees shall be elected by a majority of the membership of the corporation in the manner prescribed by the by-laws of the corporation.

ARTICLE IX - CORPORATE OFFICERS

The officers of the corporation shall be those provided by the by-laws and such officers shall perform the duties provided by the

by-laws. The pastor and secretary to the Board of Trustees shall be elected by the Trustees. The initial pastor and secretary to the Board of Trustees are stated in Article VII above.

ARTICLE X - MEMBERSHIP REQUIREMENTS

The method and conditions on which members shall be accepted, transferred, discharged and moved shall be as recited in the by-laws.

ARTICLE XI - AMENDMENTS

These articles may be amended by two-thirds (2/3) of the members voting at a meeting of the members called for that purpose when notice, as required by the by-laws, of such meeting and amendments has been given.
