ARTICLE II PURPOSE

Said corporation is organized exclusively for charitable, educational, religious or scientific purposed, within the meaning of section 501 (C) (3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

The general nature and purpose of the corporation shall be to engage in Religious services and ceremonies, to develop the whole man, mentally, spiritually, and physically.

The Corporation shall serve as a non-denominational church as permitted under the laws of the State of Florida for religious counseling, religious teaching, Preaching, religious ceremonies and day care.

ARTICLE III POWER

This corporation shall have all powers provided for corporation not for profit by Chapter 617.0202 of the Florida Statutes of corresponding provisions of any subsequent statue.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members trustees, directors, officers or other private persons, except that the corporation shall be authoized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in futherance of Section 501 (c) (3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any politicl campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code (or corresponding section of any future federal tax code) or (b) by a corporation, contribution to which are deductible under Section 170 (c) (2) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)
